IN MOST INSTANCES [LNERGO] REP HAS BEEN AWARE OF CASES AND HAS MADE APPROPRIATE ARRANGEMENTS [WITH HONG KONG SPECIAL BRANCH.] <sup>(S)</sup> TO AVOID DUPLICATION WE HAVE NOT DISCUSSED THESE CASES WITH [OUR SPECIAL BRANCH CONTACTS].

2. INFORMATION REQUESTED BY HQS ON BEHALF <sup>FBI</sup> [LNERGO] IS DEVELOPED BY HONG KONG <sup>FBI</sup> [LNERGO] [FROM SPECIAL BRANCH.] <sup>(S)</sup> A CASE IN POINT IS SUSAN FRANK (HQS 6299). LOCAL <sup>FBI</sup> [LNERGO] REP WELL AWARE OF FRANK [AND HAD ALERTED SPECIAL BRANCH.] <sup>(S)</sup> FRANK HAS NOW LEFT COLONY AND RETURNED TO U.S. <sup>FBI</sup> [LNERGO] REP HAS ADVISED <sup>FBI</sup> [LNERGO] HQS. AS A RULE LOCAL <sup>FBI</sup> [LNERGO] REP DOES NOT INFORM [STATION OF SPECIAL BRANCH] <sup>(S)</sup> REPLIES ON VARIOUS MHCHAOS SUBJECTS.
