1. [GUSTAFSON] AND OLSZEWSKI SPENT ENTIRE DAY 18 NOVEMBER SIGHTSEEING AND DINING WITH WIVES. FOLLOWING REPORTED BY [GUSTAFSON]

A. OLSZEWSKI RETURNING FROMEN PCS O/A 25 NOVEMBER. WILL CONTINUE AS COMMERCIAL REP FOR INDEFINITE PERIOD.


B. OLSZEWSKI INDICATED PRO-WESTERN VIEWS AND INTEREST IN PBPRIME IMMIGRATION AND RESETTLEMENT. MAJOR CONCERNS ARE FINANCIAL SECURITY, EDUCATION FOR TWO CHILDREN AND CONFIDENCE IN ODYCKE COMMITMENTS. HIS DREAM IS TO OWN A HOME AND LIVE IN PEACE.

C. OLSZEWSKI A LADIES MAN AND DOES NOT GET ALONG WITH WIFE WHO IS INSECURE AND POSSESSIVE.
