1. BY TIME REF RECEIVED (1800 HOURS) AMBASSADOR HAD GONE HOME FOR THE DAY. (COS)²⁷ EARLIER HAD DISCUSSED LOCAL SUMMARY OF FLEETWOOD ARTICLE IN "ULTIMAS NOTICIAS". OBVIOUSLY UNTIL FULL TEXT IN VENEZUELAN HANDS AND IF AND WHEN PRESIDENT PEREZ FOCUSES ON THIS MATTER, VENEZUELAN REACTION WILL BE UNKNOWN. MINISTER OF INFORMATION AND TOURISM ASKED AMBASSADOR ABOUT CIRCULATION AND IMPORTANCE OF "NEW TIMES" MAGAZINE- THERE BEING SOME CONFUSION IN VENEZUELAN MIND THAT THIS PART OF NEW YORK "TIMES" NEWSPAPER- AND SEEMED REASSURED BY AMBASSADOR'S REPLY DOWNPLAYING SIGNIFICANCE OF "NEW TIMES". AMBASSADOR AT THIS POINT SEES THREAT ONLY IN CAP'S TENDENCY TO ATTRIBUTE ALL UNFAVORABLE PUBLICITY IN U.S. PRESS TO ALLEGED BKHERALD EFFORTS TO DESTABILIZE GOV. IN THIS CASE CAP ALREADY KNOWS EMBASSY
