1. CARACAS AFTERNOON DAILY "EL MUNDO" OF 4 MARCH HAS FRONT PAGE STORY STATING THAT PCV ACCUSES EIGHT VENEZUELAN NEWS MEDIA PERSONALITIES OF BEING CIA AGENTS. THESE ARE: RAFAEL POLEO, FELIX MARTINEZ SUAREZ, SALFADOR ROMANI, SOFIA (IMBER) AND CARLOS RANGEL, RAMON KOESLING, OMAR LARE S, AND ROLANDO BLANCO. NAMED IN SAME ARTICLE AS "CIA SPIES" ARE ORLANDO BOSCH, RICARDO MORALES NAVARETTE, ORLANDO GARCIA VASQUEZ, ANTONIO IGNACIO BUSTILLOS PEREZ, LUIS POSADA CARRILES, FREDDY LUGO, AND HERNAN RICARDO LOZANO.

2. IT WOULD SEEM THAT THE PCV COMPILED THIS LIST FROM PREVIOUS INDIVIDUAL NEWSPAPER EXPOSES PERHAPS WITH SOME ADVICE FROM THE CUBANS. SOME OF THE ABOVE ARE EX-AGENTS, SOME ARE (LIAISON CONTACTS) AND SOME WE JUST PLAIN NEVER HAVE HEARD OF. FORTUNATELY NONE ARE CURRENTLY ACTIVE ASSETS. AS LONG AS PCV, PUBLIC, AND HOPEFULLY VENEZUELAN GOVERNMENT ATTENTION IS FOCUSED ON TARGETS
