1. ON 3 MARCH CHARGE (DCM) TALKED "INFORMALLY" TO FOREIGN MINISTER ESCOVAR SALOM, INFORMATION MINISTER DIEGO ARRIA, AND PRESIDENTIAL CONFIDANT AND UNOFFICIAL PRESS ADVISOR EUGENIO SOLER. TO ALL THREE CHARGE MADE SAME TWO BASIC POINTS WITH THOUGHT THESE WOULD BE RELAYED TO PRESIDENT PEREZ: (1) VENEZUELAN GOVERNMENT HAD MISREAD NEW YORK TIMES STORY; HAD ATTRIBUTED TO DAVID PHILLIPS STATEMENTS APPARENTLY MADE BY OTHERS; HAD OVER-REACTED TO WHAT SEEMED TO BE AN EFFORT ON PHILLIPS' PART TO BE HELPFUL; AND (2) THE USG WAS STANDING PAT ON THE PRESIDENT'S LETTER. NO ONE ELSE WAS SPEAKING, COULD OR WOULD SPEAK FURTHER FOR THE USG ON THIS SUBJECT. AS FAR AS THE U.S. WAS CONCERNED, ISSUE WAS CLOSED AND WE HOPED GOV WOULD SEE IT THE SAME WAY.

2. DURING 3 AND EARLY 4 MARCH IT APPEARS THAT THE CHARGE'S EFFORTS AND TRADITIONALLY SHORT LATIN AMERICAN ATTENTION SPAN HAVE COMBINED TO GREATLY EASE CRISIS SITUATION OF LAST WEEK, AT

LEAST AS FAR AS GOV IS CONCERNED. CAP AND GOVERNMENT SPOKESMEN HAVE ALL STATED THAT INCIDENT HAS ENDED AND ARE NOW TRYING TO DIVERT ATTENTION TO OTHER SUBJECTS. MEDIA COVERAGE IS RETURNING TO NORMAL WITH STORIES OUT OF HEADLINES AND BACK ON PAGE SIX OR EIGHT, SUPERSEDED BY NIEHOUS CASE, UGANDAN SITUATION, OPEC PRICE HIKE, ETC. 
