SUMMARY OF INFORMATION: The Agency Operator advised that Subject was calling requesting to speak to Mr. Colby.

Subject stated that he had just finished talking to "Air Chief Marshall, Dawnee," Bangkok, Thailand and had some information that he wanted to pass to Mr. Colby. Subject was informed that the Director was not available and that the undersigned would take a message and insure that the Director was informed of his call.

Subject declined SDO's invitation to leave a message and requested that the "Thai Desk" be informed of his call and then terminated the call.

Files in SR&CD reflect that Subject is generally categorized as a con man, unscrupulous, wheeler-dealer and a promoter of grandiose schemes.
