On 6/9/60, MM T-1 reported receiving information from a usually reliable source that [CARLOS GRANA] Miami, had [S] stated flights were being made from Florida to Cuba for the purpose of dropping bundles of newspapers "Patria" and "Cuba Libre." Promptly interview [Carlos Grana.] Patria Libre,  
Cuba Libre and Jose Acosta are subjects of pending  
investigations in your office. [Pertinent data developed  
concerning alleged plane flights from Florida to Cuba] (S) (U)  
should be made available to INS, Customs and FAA, locally.  
Determine from [Grana] the basis for his allegations. Pin  
him down particularly concerning his belief that the  
counterrevolution will begin in Cuba in about June, 1960.  
Elicit from him any concrete data he may have concerning  
the alleged clandestine air base being prepared in  
Yucatan Province, Mexico. ] (S) (U)

No identifiable information concerning Grana  
was located in Bufiles on the basis of information furnished.  
If Grana is active in anti-Castro activities, consideration  
should be given to instituting a separate investigation of  
him to determine if he is working in behalf of a foreign  
principal and to determine the nature and extent of his  
involvement in anti-Castro activities.

New York check with Rafael Diaz Salart for any  
substantiation of [Grana's data concerning him.] (S) (U)

Mexico promptly advise the Bureau if the event  
there is any substantiation to the report that a clandestine  
air base is being prepared somewhere in Yucatan Province.  
It is noted that previous inquiries by your office have  
failed to substantiate similar allegations. (S) (U)

publications. Jose Acosta reportedly is connected with these

revolutionary army. [Grana] also believes that counterrevolution  
will begin in June, 1960, and that a clandestine air base
