AMBASSADOR HAD BEEN TOLD BY LEGAT THAT RICARDO MORALES NAVARRETE  
WAS FORMER SOURCE OF INFORMATION OF FBI, MIAMI, AND HAS NOW BEEN  
APPRISED THAT MORALES WAS PAID INFORMANT OF THAT OFFICE. HE IS  
AWARE THAT MORALES AND ORLANDO GARCIA VASQUEZ HAVE BEEN LIAISON  
CONTACTS OF LEGAT BUT HAVE NEVER BEEN PAID INFORMANTS OF THE
