Enclosed are two autostat copies of a "Secret" CIA memorandum to the Ambassador dated 10/16/63 and captioned "Lee OSWALD/Contact with the Soviet Embassy." It will be noted that this memorandum bears the statement "THIS INFORMATION IS FROM A CONFIDENTIAL SOURCE. IT MUST NOT BE DISSEMINATED IN WHOLE OR IN PART OUTSIDE YOUR OFFICE WITHOUT PRIOR APPROVAL FROM THE ORIGINATING OFFICE IN MEXICO CITY." It is also noted that the original of the memorandum was sent on a circulating basis to the Ambassador, the Minister, the Counselor for Political Affairs, and the Regional Security Officer and was to be returned to the 9th Floor (CIA) and that carbon copies for retention were designated for the Legal Attache, the Naval Attache, and I&NS.

ReBucab #22 and mycab #525, both dated 4/3/64. In accordance with the instructions contained in reBucab, the following is submitted:

It is noted that the enclosed CIA memorandum mentions contact on the part of LEE OSWALD only with the Soviet Embassy and no mention was made of the Cuban Embassy. Although the CIA memorandum was dated 10/16/63, the blockstamp of this office indicates it was actually received here on 10/18/63. On the same date our cable #109 captioned "LEE OSWALD, IS - R," was sent to the Bureau. This cable furnished a summary of the information contained in the CIA memorandum and requested the Bureau to furnish background data to this office. Bureau cable #743 dated 10/22/63 and bearing the same caption furnished such background and advised that additional background was being furnished by mail. This additional background information was received at the Mexico City Office on 10/28/63.

SUBJECT: Assassination of President Kennedy--Reported
Anonymous Telephone Message

1. The following ^(S) cable from the CIA Station in London was reported orally to Mr. Samuel Papich at 0930 on 23 November:

2. The British Security Service (MI-5) has reported that at 1805 GMT on 22 November an anonymous telephone call was made in Cambridge, England, to the senior reporter of the Cambridge News. The caller said only that the Cambridge News reporter should call the American Embassy in London for some big news and then hung up.

3. After the word of the President's death was received the reporter informed the Cambridge police of the anonymous call and the police informed MI-5. The important point is that the call was made, according to MI-5 calculations, about 25 minutes before the President was shot. The Cambridge reporter had never received a call of this kind before and MI-5 state that he is known to them as a sound and loyal person with no security record.

4. MI-5 noted that similar anonymous phone calls of a strangely coincidental nature have been received by persons in the U. K. over the past year, particularly in connection with the case of Dr. Ward.

5. The British Security Service stated its desire to assist in every possible way on any follow-up investigations required within the United Kingdom.

SUBJECT: Lee Harvey OSWALD - Internal Security
Russia - Cuba

1. Reference is made to your memorandum of August 14, 1964, Subject as above, your file number (S) 105-82555, in which you requested that seven enclosed photographs be shown to VIADUCT and certain questions be asked of him.

2. VIADUCT was interviewed on 9 September 1964 with the following results.

3. Photograph no. 1:

- (1) Nikolay SERGEYEV - Source did not recognize the face and had never heard the name.
- (2) Annette (Anita) SETYAEVA, nee ZUGOFF, formerly known as Annette GOLDSHTEYN (GOLDSTEIN) and Annette Henkina (KHENKINA): Source recognized her immediately by face, giving the name Annette KHENKINA, formerly Annette GOLDSHTEYN. He could not recall her maiden name but when offered the name ZUGOFF he said this would be correct as it is an Ossettian name and her father had been Ossettian and her mother a Canadian. Source's additional information on this woman is provided in paragraph 8 below.
- (3) Joseph ADAMOV: Source recognized his photograph immediately and provided the name correctly, identifying him as his long-time friend, previously discussed in the [British] report referenced in your memorandum.

- (4) Annabelle BUCAR: Source recognized her photograph immediately and gave her name correctly. She is the person discussed in the [British] (3) report.
- (5) Sergei RUDIN: Source recognized his photograph immediately and gave his name as "RUDIK" and RUDERMAN or RUDIMAN, the same man referred to in the [British] report. Source said he is a close friend of Joe ADAMOV's. He is Jewish and was originally from New York, but is now a Soviet citizen, married to a Russian woman and father of three or four children. He works in the English language section of Radio Moscow. He had formerly had a very small flat of one or two rooms, with which he was very unhappy, but Radio Moscow got him an attractive and larger flat in a building on Peschanaya Street.
- (6) Lucy (Olga) PRAVDINA: Source recognized her photograph at once as the woman who had given him English lessons in 1944 or 1945 when he was briefly employed at [Radio Moscow]. He believed her name was Irina or something like that, and she had previously spent possibly ten or fifteen years in the United States with her husband who had been a TASS man there. Source could not recall her last name (married name) but thought it began with a "K". When Source first met her she was a program director for Radio Moscow and did some announcing. He said she spoke excellent English, was a good worker and well liked by her colleagues. He did not know the names LUCY and OLGA PRAVDINA, and was certain neither was her actual name.

4. Photographs 2 and 3: Source recognized these as Annette KHENKINA, of paragraph 3 (2) above.

5. Photograph no. 4: Source recognized number 1 as the person identified in paragraph 3 (6) above; and recognized Annette KHENKINA, Sergei RUDIMAN, and Joe ADAMOV. He did not recognize Nikolai SERGEYEV in this photograph.

6. Photograph no. 5: Source recognized all persons in this photo, as identified in paragraphs 3 (3), (2), (4), and (5) above.

7. Photograph no. 6: Source recognized number (1) as KHENKIN (first name not recalled), the second husband of Annette GOLDSHTEYN KHENKINA, and number (2) as Annette herself. He knew that they had a son and assumed that the child in this photo was that son, but he had never seen the child. Source provided the same information on KHENKIN previously included in MI-5 Report Number 27⁶ referred to in your memorandum. He added to this that the apartment building in the background of photograph number (3) is the location of the apartment which KHENKIN was given after he had written a letter to STALIN complaining of quarters he was first given when he repatriated to the Soviet Union in 1945 or 1946.

8. Photograph no. 7: Source recognized Annette KHENKINA, but did not know any of the others in the photo. When number (4), Marina, was pointed out to him, he stated that she was the right age to be Annette's daughter by her first husband, GOLDSHTEYN. Source had seen her as a small child, possibly about five or six years of age, in 1945. He has never seen her since, knew nothing more about her, and could not identify her photograph. Source commented that he had never met GOLDSHTEYN, Annette's first husband, but knew that he was much older than she and he speculated that the older man in this photograph might be Boris GOLDSHTEYN. Source gave the following additional information on Boris GOLDSHTEYN: He was some kind of engineer-technician, not employed by Radio Moscow. He did not approve of Annette's working in the radio field, and disapproved of the people she worked with there and the general atmosphere of work. Annette was already separated or divorced from GOLDSHTEYN when Source first met her, sometime in 1944 or 1945. While Annette was still married to GOLDSHTEYN, she had an affair with Joe ADAMOV.

9. Regarding Lev or Leo SETYAEV, Source had never heard the name. He was not aware that Annette KHENKINA had married for the third time, although he knew that she was divorced from KHENKIN and that he was interested in marrying a woman who was an editor in a publishing house.

10. Source had never heard of Lee Harvey OSWALD prior to his defection, and had no information regarding his participation in a Radio Moscow interview in late 1959. He commented, however, that it was not unusual to

Reference is made to our letter in this case dated July 22, 1964, dealing with Oswald's possession of the name Lev or Leo Sotynov, an announcer at Radio Moscow, and his reference in personal papers to having participated in a taped interview broadcast by Radio Moscow, probably in late 1963. Reference is also made to British Security Service, MI-3 Report Number ~~77~~ (U) captioned "Personalities in Radio Moscow Known to Tinslet," a copy of which is believed to be in your possession. Further reference to Lev Sotynov and his current wife, Annette (Anita) Sotynova, nee Ruzoff, is contained in your letter in this case dated February 20, 1964, your reference CSCI-2/779,963.

With reference to the matter at hand, there are enclosed seven photographs described as follows:

- (1) A photograph of six individuals who were reportedly members of the North American Section of Radio Moscow as of June, 1960. The date of this photograph is unknown. The individuals depicted therein from left to right are reportedly identifiable as follows: (1) Nikolai Sotynov; (2) Annette (Anita) Sotynova, nee Ruzoff, formerly known as Annette Goldsteyn (Goldstein) and

(5) Photograph of Radio Moscow personnel reportedly taken September 9, 1958. Depicted therein from left to right are Adamov, Setyaeva, Ducar and Rudin.

(6) Photograph reportedly taken June 1, 1957, depicting (1) adult male, one (First Name Unknown) Henkin; (2) Annette Setyaeva, formerly Henkina; and (3) child, Kostia Henkin.

(7) Photograph of wedding party, depicting (1) at far left, head of Annette Setyaeva; (2) her son Kostia Henkin; (3) unknown female; (4) Annette Setyaeva's daughter, Marina, maiden name unknown, but probably Goldsteina (Goldstein); (5) Vashi (Last Name Unknown), husband of Marina; and (6) four unknown individuals, two males and two females.

Of the various individuals depicted in the enclosed photographs, Joseph Adamov is believed identical to the person of same name who is referred to in paragraph two of British Security Service Report Number 27, referred to above; and Annabelle Ducar is believed identical to the person referred to in paragraph six of the report. Sergei Rudin is likely identical with the Rudinan referred to in paragraphs eleven and 17 of the [British report]. ~~(U)~~ (U)

Annette Setyaeva is believed to be identical with the Annette Goldstein (Khenkina) referred to in paragraph 14 of the report. This person was born October 18, 1918, at Lake Stevens, Washington, to William E. Engoff, a Russian national, and Lillie May Edwards who was born at Northland, Michigan, in 1902. Setyaeva's mother, presently known as Lillie May Rahn, resides at Ketchikan, Alaska.

We would also appreciate any biographical data including descriptive material that Viaduct may be able to furnish concerning Lev or Lee Setyshev and we would like to have Viaduct's views as to how Setyshev's name came to be in the possession of Lee Harvey Oswald. Finally, we would like to know if Viaduct can furnish any information concerning the possible participation by Oswald in a taped interview broadcast by Radio Moscow in late 1959.

Classified "Secret" (as MI-3 and CIA have so classified previous communications concerning the matter at hand. Viaduct, a low-level KGB agent who defected to the British in 9/53, is presently in the U. S. under CIA control. His bonafides have not been established and he is suspected to be a plant. CIA, according to Papich, plans to extensively interview him in an effort to reach a conclusion as to his bonafides. He was a writer and was associated with Radio Moscow in the late 1950s and (U) MI-3 Report Number 27 sets forth considerable information concerning individuals associated with Radio Moscow, some of whom he suspects to be in the service of the KGB. From personal papers of Oswald, it is believed he engaged in a broadcast over Radio Moscow in late 1959. He admitted this to his wife who cannot furnish further details. Viaduct may be able to fill us in in this regard.
