It is noted that information concerning captioned organization is set forth in [CIA] letter and enclosures to the Bureau 12/18/67 re "TASS Interest in World Wide Information Services, Inc.; IS - USSR," which were forwarded to WFO and NYO by the Bureau under the caption, "TASS NEWS AGENCY; IS - R" (Bufile 100-183386). [In the letter from CIA, HUBBELL is described as a reliable source of CIA.]

WFO files indicate that JOHN FURFEY (CIA covert) advised on 1/4/68 that WILLIAM KENT (CIA covert) was employed as the Washington representative of captioned service.

In view of the above, UACB, WFO will not review files of CIA per lead in relet at this time. It is suggested, instead, that the Bureau might obtain pertinent information from CIA through liaison, if this appears advisable.

WFO indices contain no reference to ADOLPH BOLM, or to anyone else with the surname, BOLM.

In connection with HUBBELL's wife, KYRA D. HUBBELL, it is noted that report of SA BERYL M. GOODENOW, Los Angeles, dated 9/29/48, re "BORIS MICHAEL MORROS; ESP - R"
