ReAirtel noted CIA requested Bureau ascertain from subject whether he had been in contact with [EDUARDO ANDRES OJEDA (CAMARAZA)] and [ORLANDO BARBARO SANS MATEU] on January 18, 1961. (S) (U)

This matter was casually brought up during interview conducted with subject on February 16, 1961, in such a manner as not to arouse any suspicion on his part. Subject stated he was not acquainted with any individuals bearing these names, although it was possible that he may have met them in Cuba at some time or other. He stated he had spent the two weeks prior to his flight from Cuba on 1/26/61, in Havana, preparing for his departure, and that his only contact with anyone during that period had been with the group of close aides who accompanied him to the United States.
