On September 3, 1963, Mrs. Jane Roman, CIA, made reference to CIA letter dated April 18, 1963, which dealt with Levi Laub. The reference communication indicated that CIA had received its information from a British national named Gavin Young *[Signature]*

Mrs. Roman stated that Maurice Oldfield, the local MI-6 representative, has advised CIA that Young is now in New York City. Oldfield is in a position to direct any questions to Young. Oldfield has also indicated that if the Bureau prefers direct access to Young, suitable arrangements can be made for such an interview. *[Signature]*

ACTION: Subversive Control

The above information is being directed to the attention of the Nationalities Intelligence Section. In the event that we wish to interview Young, it is suggested that Oldfield be contacted through CIA. *[Signature]*
