This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on October 18, 2016, for information pertaining to a copy of records, to include emails sent to and from Congressional Relations/Legislative Relations Liaison Officer, Chris Stanley, which contain the word 'Clinton', from January 1, 2015.

After a detailed review of all potentially responsive records, 50 page(s) were released and 0 page(s) were withheld in their entirety. Exemptions under the FOIA Statute, Title 5 U.S.C. § 552 have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.



**FREEDOM OF INFORMATION ACT
SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552**

Provisions of the Freedom of Information Act do not apply to matter that are:

- (b) (1) (A) specifically authorized under criteria established by an Executive Order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified pursuant to such Executive order;
- (b) (2) related solely to the internal personnel rules and practices any agency;
- (b) (3) specifically exempted from disclosure by statute (other than section 552b of this title), if that statute: (A)(i) requires that the matters be withheld from the public in such a manner as to leave no discretion on the issue, or (ii) establishes particular criteria for withholding or refers to particular types of matters to be withheld; and (B) is established after the date of enactment of the OPEN FOIA Act of 2009;
- (b) (4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b) (5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency; provided that the deliberative process privilege shall not apply to records created 25 years or more before the date on which the records were requested;
- (b) (6) personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;
- (b) (7) records or information compiled for law enforcement purposes, but only to the extent that the information: (A) could reasonable be expected to interfere with enforcement proceedings; (B) would deprive a person of a right to a fair trial or an impartial adjudication; (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy; (D) could reasonable be expected to disclose the identity of a confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of a record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source; (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law; (F) could reasonably be expected to endanger the life or physical safety of any individual;
- (b) (8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for regulation or supervision of financial institutions;
- (b) (9) geological and geophysical information and data, including maps, concerning wells.

Subj: Upcoming Protective Events

As you are aware, the Secret Service is responsible for coordinating multiple significant protective operations over the next several months. These include the visit of Pope Francis to Philadelphia, New York, and Washington, as well as the 70th Annual Meetings of the United Nations General Assembly (UNGA-70). President Obama is also expected to engage in substantial domestic and overseas travel, to include a major trip to Africa this month, and a two week trip to Martha's Vineyard in August. In addition, the early stages of the 2016 campaign are underway. In response, the Secret Service has begun providing additional protective resources to enhance the protective detail assigned to Mrs. Clinton, and is continuing preparatory steps in anticipation of additional candidates being authorized protection. Meanwhile, we must also continue to perform all of our other protective functions, to include protecting the White House, Vice President's Residence, and providing appropriate protective measures for all of our other protectees.

What we are facing over the next few months will be a substantial challenge to all of us, and we realize that it will not be easy. Here are just a few of the highlights:

- Pope Francis will visit the United States from September 22-27, 2015 to include Washington, DC (September 22-23); New York City, NY (September 24-25); and Philadelphia, PA (September 26-27).
- There will be major indoor and outdoor events for the Pope in each city, to include parades along major thoroughfares that are expected to attract hundreds of thousands of spectators at each site. Further, Pope Francis will conduct an outdoor mass in Philadelphia that could draw 2.2 million people or more.
- The Papal visit will occur during the time of UNGA-70, which is expected to attract upwards of 170 Heads of States and 60+ spouses.
- The President will speak at the UN on Monday, September 28th. The week of September 28th - October 3rd is expected to be the busiest week for UNGA-70. In addition, the Clinton Global Initiative will also occur in New York during September 26-29, 2015.

It is important to note that although planning for each these events has not yet been finalized, we want you to know some of the actions that have already been undertaken to

lessen the burden on our employees. For example, when the Pope's visit was announced, Secret Service representatives undertook an extensive educational campaign for counterparts concerning the expected security requirements for the visit. As a result of these discussions, the Secretary of Homeland Security designated the Pope's visit and UNGA-70 as National Special Security Events (NSSEs). The NSSE designations will be of substantial benefit to the law enforcement and public safety agencies at the State and local level, as well as the Secret Service, since the designations will facilitate access to additional Federal resources.

Besides the NSSE designations, several other actions have also been accomplished to provide additional assets to support our protective requirements. For example, (b)(7)(E)

Substantial efforts have also been undertaken to ensure that we have sufficient financial resources for these protective activities. The Office of the Chief Financial Officer (CFO), the Office of Government and Public Affairs (GPA), and the Office of Protective Operations (OPO) have engaged in numerous briefings with the Department of Homeland Security, the Office of Management and Budget, and Congress to explain our protection-related financial requirements. Further, many more hours have gone into developing written justifications for our financial needs, and putting together complicated reprogramming requests, in order to obtain additional funding. All of this hard work has resulted in the Secret Service receiving in FY 2015 approximately \$50.3 million in funding for the Papal and UNGA-70 NSSEs, and about \$21.5 million for start-up activities related to the campaign.

While all of the efforts described above have not always been visible, they are essential in providing the assets and resources necessary to ensure our workforce will be successful in completing the significant protective challenges that remain ahead. We can assure you that the entire Executive Staff is continuously working to obtain additional assets and resources, and we are striving to tell "the Secret Service story" in a meaningful and persuasive way to those who have oversight of our budget. Further, the Director and Deputy Director are committed to competing for additional funding, not just in the immediate future, but for as long as necessary to ensure the long-term financial health of our organization.
