This is the final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated March 1, 2019, and received by this office on March 4, 2019. You are seeking the following:

- 1. FOIA Case Log for 2018;
- 2. FOIA Appeals Log for 2018; and
- 3. Mandatory Declassification Review (MDR) Log for 2018, including the case number, date submitted, date closed, name of requester, and subject/topic of request

Information responsive to item 1 of your request can be accessed online at https://www.dhs.gov/dhs-privacy-foia-logs, accessed on May 3, 2019. Pursuant to Title 5 U.S.C. § 552 (a)(1) and (a)(2), DHS need not make available under FOIA records that are publicly available.

A search of the FOIA Xpress for records pertaining to item 2 of your request produced 20 pages that are responsive to your request. After review of those documents, I have determined that 16 pages are partially releasable and 4 pages are released in their entirety, pursuant to Title 5 U.S.C. § 552, (b)(6), exemption 6 of the FOIA as described below.

FOIA Exemption 6 exempts from disclosure personnel or medical files and similar files the release of which would cause a clearly unwarranted invasion of personal privacy. This requires a balancing of the public's right to disclosure against the individual's right to privacy. The privacy interests of the individuals in the records you have requested outweigh any minimal public interest in disclosure of the information. Any private interest you may have in that information does not factor into the aforementioned balancing test.

With respect to item of 3 of your request, we conducted a comprehensive search of files within the DHS Privacy Office for records that would be responsive to your request. Unfortunately, we were unable to locate or identify any responsive records.

You have a right to appeal the above withholding determination and search results. Should you wish to do so, you must send your appeal and a copy of this letter, within 90 days of the date of this letter, to: Privacy Office, Attn: FOIA Appeals, U.S. Department of Homeland Security, 245 Murray Lane, SW, Mail Stop 0655, Washington, D.C. 20528-0655, following the procedures outlined in the DHS FOIA regulations at 6 C.F.R. Part 5 § 5.8. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS FOIA regulations are available at www.dhs.gov/foia.

Additionally, you have a right to right to seek dispute resolution services from the Office of Government Information Services (OGIS) which mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974. Provisions of FOIA allow DHS to charge for processing fees, up to \$25, unless you seek a waiver of fees. In this instance, because the cost is below the \$25 minimum, there is no charge.

And by definition a statement supported by specific facts cannot be "conclusory in nature." "The acknowledgement letter also conditionally granted EPIC's request for a fee waiver. The letter stated that a fee waiver determination will be based upon a "sampling" of responsive documents as a result of the search conducted for EPIC's FOIA Request. EPIC has reviewed the methodology for determining a fee waiver and it is not correct. In an appeal of the same OHS fee response in a different FOIA matter, the administrative law judge determined that the DHS may not use a "sampling" methodology to determine fee waivers."
