Dear Mr. Carlson:

I am in receipt of your affidavit with the information requested and wish to thank you for your prompt reply.

Now there is one more thing which I would like to have cleared up, and then shall bother you no more.

The figure "6" on my Woodstock Typewriter #222,402 which was manufactured in March or April of 1929 is similar to the figure "6" on my other Woodstock which I have in my shop, #209455, and which also is similar to the Woodstock #230,000 which my customer has, and about which he asks for information, which in turn, I ask you.

You will note on samples of "6" on enclosed sheet, written on Woodstock #229402 and on Woodstock #209455, the top half is longer, and the terminal is more in the "center" of the type, than the "6" on the Woodstocks #343952 and #360719, which tops are shorter, more rounded, and terminal is to the "right of center" so to speak.

Now to be truthful, I don't know how or where or why this attorney wants to use this information, but it seems to me there is some matter in court and it is of the greatest importance to him to know "why" the "6" on his Woodstock is different than those on older and later than his Woodstock, and is especially interested to know, from your company, if this "6" was used during a certain period--say, during the year that his 230,000 and my 222,402 and 209,455 were manufactured. (I have no more Woodstocks to test of similar age for similar "6"---)

Therefore, kindly try to ascertain from records, old time Woodstock mechanics--and any other source available--if this peculiar "6" was used only a certain period, and the best information as to which period these "6"'s were used, and when changed to the rounder ones--

This is of greatest importance, and do hope you will be successful in letting me have this information by return mail--and I shall bother you no more.

Dear Mr. Lockwood:

In order to answer the questions propounded in your communication of October 19, 1950 in a convincing manner, Mr. Goldblatt and the writer spent some twelve hours locating four Woodstock typewriters of 1928, 1929, 1934 and 1937 vintage in the Chicago area and in personally getting the samples therefrom that are photostatically reproduced on the sheet hereto attached.

At the top of said sheet Mr. Goldblatt states that he used the same ribbon on all four machines. He failed to say that he also cleaned the type on each machine before typing the samples submitted.

Careful study of these samples should indicate how utterly impossible it is for anyone to say and to demonstrate how many and what age typewriters were used in typing Exhibits A, B, C, D, E, F, G and H of our report of October 9, 1950. There are no type defects apparent in said exhibits. Likewise there are no type defects apparent in the specimens hereto attached.

It is a well-known fact that the Woodstock company made no change in type design prior to 1940. Beginning with serial number 500,000 in 1940, the Woodstock company enlarged the size of its type but did not change the design of its type.

In our report of October 9th we assumed that Exhibits A, B, C, D and E were written on the dates they bear and that accounts for our statement in opinion No. 2 that the serial number would be under 145,000.

In our report of October 9th we also made the statement, "There is plenty of data in support of our opinion that at least five different persons had a hand in typing the eight documents that are photographically reproduced in Exhibits A to H, both inclusive, of this report". In support of this statement we refer you to the fact that Exhibit A has no identifying initials as to the did the typing. The quality of the typing indicates that it was done by Thomas L. Fawler. Exhibit B was typed by a person indicated by initial L. That is also true of Exhibit C. Exhibit D was typed by a person using the initials AS. Exhibit E was not typed by any of the persons who typed the preceding exhibits. Exhibit F is the product of a typewriter man, not a stenographer. The same is true of Exhibits G and H. Exhibits G and H are the product of the same typewriter man. It is apparent that two different ribbons were used, which again raises the question whether they were ribbons on two different machines, or were changed for a purpose on the same machine.

We trust that we have succeeded in convincing you how utterly impossible

I am in receipt of your affidavit with the information requested and wish to thank you for your prompt reply.

Now there is one more thing which I would like to have cleared up, and then shall bother you no more.

The figure "6" on my Woodstock Typewriter #222,402 which was manufactured in March or April of 1929 is similar to the figure "6" on my other Woodstock which I have in my shop, #209455, and which also is similar to the Woodstock #230,000 which my customer has, and about which he asks for information, which in turn, I ask you.

You will note on samples of "6" on enclosed sheet, written on Woodstock #222402 and on Woodstock #209455, the top half is longer, and the terminal is more in the "center" of the type, than the "6" on the Woodstocks #343952 and #360719, which tops are shorter, more rounded, and terminal is to the "right of center" so to speak.

Now to be truthful, I don't know how or where or why this attorney wants to use this information, but it seems to me there is some matter in court and it is of the greatest importance to him to know "why" the "6" on his Woodstock is different than those on older and later Woodstocks, and is especially interested to know, from your company, if this "6" was used during a certain period--say, during the year that his 230,000 and my 222,402 and 209,455 were manufactured. (I have no more Woodstocks to test of similar age for similar "6"---)

Therefore, kindly try to ascertain from records, old time Woodstock mechanics--and any other source available--if this peculiar "6" was used only a certain period, and the best information as to which period these "6"'s were used, and when changed to the rounder ones--

This is of greatest importance, and do hope you will be successful in letting me have this information by return mail--and I shall bother you no more.

On October 9, 1951, ROBERT C. GOLDBLATT, not ROINFELATT, Star Typewriter Company, 189 West Madison Street, Chicago, Illinois, was interviewed by SA ROBERT K. SCURRY. It is noted that Mr. GOLDBLATT is advanced in years and appears to be forgetful, but after a time, did recall that he had in file correspondence in connection with instant matter. This correspondence has been photostated and will be described below.

To the best of GOLDBLATT'S recollection, his association with this matter was as follows:

In October, 1950, MANICE De LOCKWOOD, of a New York law firm, approached G. W. SCHWARTZ and Daughter, professional examiners of questioned documents, at 10 South La Salle Street, Chicago, Illinois. LOCKWOOD asked them to conduct certain typewriting examinations on a confidential basis. GOLDBLATT, who regularly does typewriting examinations for SCHWARTZ and Daughter, actually did the examination. He is not certain as to what these examinations consisted of, but SCHWARTZ'S letter to LOCKWOOD, dated October 24, 1950, a copy of which is enclosed, offers some explanation.

Before or after these examinations, but probably before, and about one month prior to LOCKWOOD'S personal visit to GOLDBLATT, which is described below, two men came to GOLDBLATT'S shop asking to see any Woodstock typewriters of about 1927 vintage. GOLDBLATT stated that one of the men is named TITELL and is the owner of the Tytell Typewriter Company, New York City. He said he knew TYTELL because the latter is considered unethical with the Chicago typewriter Dealers Association since he sells typewriters below established prices.

GOLDELAFF displayed an old Woodstock to these men who were particularly interested in its number. TITELL had a magnifying glass and appeared to take but a very quick look at one section of the keyboard. GOLDELAFF now thinks that he looked at the number "6" and when it was not the type he wanted, he had no further interest in the machine.

In November, 1950, LOCKWOOD personally called on GOLDELAFF and expressed interest in the Woodstock No. "6." He wanted an affidavit as to the year the "6" was changed, and also wanted to know the exact dates no. 230,000 and 222,402 were made, and an affidavit as to the date of manufacturing of 222,402. With regard to the No. "6" GOLDELAFF explained that the Woodstock once used an open top "6" but subsequently changed to one with a rounded top. As to the affidavits LOCKWOOD requested, one was actually furnished and executed by J. T. CARLSON, Vice-President, R. C. Allen Business Machines, Inc., Woodstock, Illinois, at the request of GOLDELAFF. This affidavit is referred to in GOLDELAFF'S letter of November 17, 1951, and has reference to dates of manufacture of Nos. 222,402 and 230,000. In letter dated November 21, 1950, GOLDELAFF set forth a copy of a letter from CARLSON regarding the No. "6."

As to the conversation between LOCKWOOD and GOLDELAFF, the latter recalls that he asked LOCKWOOD whether he was working for the FBI or for HISS, and received the answer that it made no difference. He could recall nothing further regarding their conversation except that LOCKWOOD had flown to Chicago and would return to New York by plane.

GOLDELAFF now believes that he saw LOCKWOOD but once. He said that he believes that LOCKWOOD gave him \$25 at the time of his personal visit, and that the second payment actually came from SCHWARTZ. SCHWARTZ had learned that LOCKWOOD had gone directly to GOLDELAFF after LOCKWOOD had first consulted SCHWARTZ, and SCHWARTZ protested that this was not ethical. Thereupon LOCKWOOD gave SCHWARTZ \$300 who turned over \$100 or 150 to GOLDELAFF.

This office has no derogatory information regarding GOLDELAFF and no identifiable record regarding G. J. SCHWARTZ and Daughter.
