This is our final response to your Freedom of Information Act (FOIA) request of 12 December 2005 for a copy of the administrative tracking file associated with FOIA Case #19136. A copy of your request is enclosed. You were advised in our initial response that for purposes of this request and based on the information you provided in your letter, you are considered an "all other" requester. As such, you are allowed 2 hours of search and the duplication of 100 pages at no cost. There were no search costs associated with this request, and, as anticipated, duplication fees are minimal; therefore, no fees are assessed for this request. Your request has been processed under the FOIA, and some of the documents you requested are enclosed. Certain information, however, has been deleted from the enclosures, and three documents (22 pages) have been withheld in their entirety.

Some of the information deleted from the documents was found to be currently and properly classified in accordance with Executive Order 12958, as amended. This information meets the criteria for classification as set forth in Subparagraphs (b), (c), and (g) of Section 1.4 and remains classified TOP SECRET, SECRET, and CONFIDENTIAL as provided in Section 1.2 of the Executive Order. The information is classified because its disclosure could reasonably be expected to cause exceptionally grave damage to the national security. Because the information is currently and properly classified, it is exempt from disclosure pursuant to the first exemption of the FOIA (5 U.S.C. Section 552(b)(1)).

In addition, this Agency is authorized by various statutes to protect certain information concerning its activities. We have determined that such information exists in these documents. Accordingly, those portions are exempt from disclosure pursuant to the third exemption of the FOIA which provides for the withholding of information specifically protected from disclosure by statute. The specific statutes applicable in this case are Title 18 U.S. Code 798; Title 50 U.S. Code 403-1(i); and Section 6, Public Law 86-36 (50 U.S. Code 402 note).

Some of the information has been deleted from the enclosures pursuant to the fifth exemption of the FOIA. This exemption applies to inter-agency or intra-agency memoranda or letters, which would not be available by law to a party in litigation with


the agency, protecting information that is normally privileged in the civil discovery context, such as information that is part of a predecisional deliberative process.

In addition, Subsection (b)(2) of the FOIA exempts from disclosure matters related solely to the internal personnel rules and practices of an agency. This exemption has been held to apply to matters that are "predominantly internal," the release of which would "significantly risk circumvention of agency regulations or statutes." Crooker v. Bureau of Alcohol, Tobacco, and Firearms, 670 F.2d 1051, 1074 (D.C. Cir. 1981). Information contained within the enclosures meets the criteria for Exemption (b)(2) protection as that statutory provision has been interpreted and applied by the Federal Judiciary. The information being protected under Subsection (b)(2) is limited to e-mail routing information that appears before the text of a message and would reveal how NSA's information network is constructed. The release of such information could expose the network to unauthorized access and is classified CONFIDENTIAL.

Since three documents were withheld in their entirety and information was withheld from the enclosures, you may construe this as a partial denial of your request. You are hereby advised of this Agency's appeal procedures. Any person denied access to information may file an appeal to the NSA/CSS Freedom of Information Act Appeal Authority. The appeal must be postmarked no later than 60 calendar days from the date of the initial denial letter. The appeal shall be in writing addressed to the NSA/CSS FOIA Appeal Authority (DJP4), National Security Agency, 9800 Savage Road STE 6248, Fort George G. Meade, MD 20755-6248. The appeal shall reference the initial denial of access and shall contain, in sufficient detail and particularity, the grounds upon which the requester believes release of the information is required. The NSA/CSS Appeal Authority will endeavor to respond to the appeal within 20 working days after receipt, absent any unusual circumstances.

The Central Intelligence Agency (CIA) has asked that we protect information pursuant to 5 U.S.C. 552 (b)(1), (b)(3) and (b)(5). Those deletions have been marked with the code OGA (Other Government Agency). Any appeal of the denial of CIA information should be directed to that agency.

Currently, the scope of his request is for "documents in the year 1970 concerning 'non-secret digital encryption' described in the paper by J H Ellis, 'The Possibility of Secure Non-Secret Digital Encryption,' CESC Report, January 1970, and documents concerning public key cryptography by the USA or other nations;" and "Should NSA have no documents about 'non-secret digital encryption' and public key cryptography for the year 1970, then I request documents on the topics from the earliest year other than 1970."

(U) We inform Mr. Young that documents have been referred to another organization for direct response, and others have been referred for consultation and return to NSA. Our review is near completion upon receipt of the external review. We also calculated that the cost estimate he paid for was significantly higher than the actual costs, so we inform him that he will be refunded \$4107.70 under separate cover. We did not want to wait for the case to be complete since he had overpaid so much (and we've held it for several years). We have held back enough funds to cover the estimated duplication of 180 pages (100 free). We concurrently send a memo to Finance to refund the money.

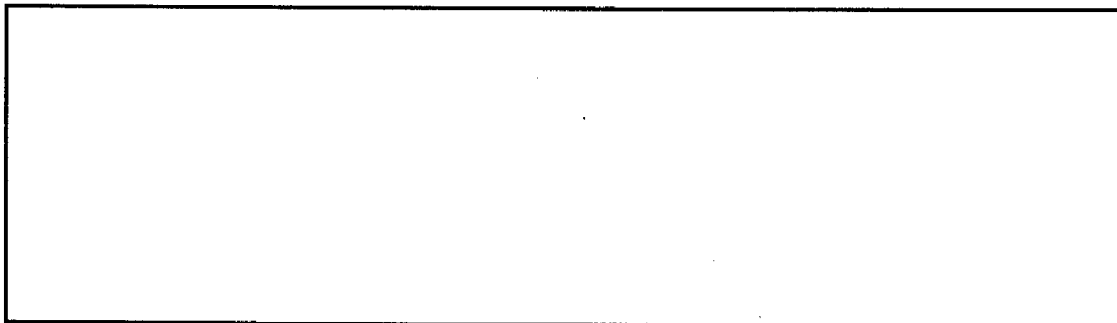

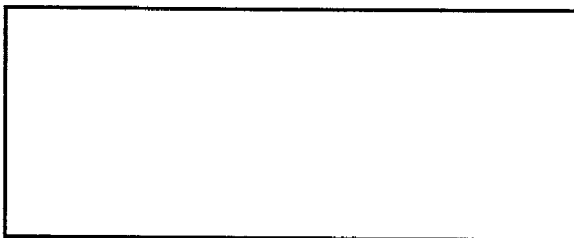

(U) REQUEST SUMMARY: The attached letters relate to Mr. John Young's narrowed FOIA request of 8 September 2001 for:

- Documents in the year 1970, or the earliest year other than 1970, concerning "non-secret digital encryption" as described in the paper by J. H. Ellis, "The Possibility of Secure Non-Secret Digital Encryption," CESG Report, January 1970;
- Documents concerning public key cryptography by the USA or other nations.

(U) CASE HISTORY: This case is the result of a resubmission of a 6 October 1999 request originally assigned J9022-00, which was closed 13 December 1999 for non-payment of search estimate fees. The requester lost our 10 November 1999 letter asking for payment of those fees, and on 6 October 2000 he requested another copy of the letter, saying he wanted to pay. We explained the situation, and told him he'd have to resubmit. After receiving his 16 November 2000 resubmission, we did an update to the search estimate for the time lapse between the first request and the resubmission, and came up with a revised cost estimate (previous search estimate plus search estimate for update period), which the requester paid 23 April 2001. We then started processing the new case (19136) with an actual search starting 26 April 2001. In response to a phone conversation with the FOIA Office, the requester narrowed his request by specifying documents in the year 1970 (or earliest year other than 1970) concerning "non-secret digital encryption" described in the paper by J. H. Ellis, "The Possibility of Secure Non-Secret Digital Encryption," CESG Report, January 1970, and documents concerning public key cryptography by the USA or other nations. This caused the case to be changed from the HQ to the EQ.
