GREATER THAN THOSE GRANTED BULLGAR A AND EAST GURMANY BEFORE HUNG EVENTS AND MUCH LESS ADVANTAGEOUS THAN RECENT CONCESSIONS TO POLAND. INCREASED SUPPLIES 1987 SOV FAW MATERIALS AND PRODUCTS FOR RUMANIAN METALLURGICAL INDUSTRY AGRETATION PREVIOUSLY. AT LEAST IN PRINCIPLE, (EMB DESPATCH 180 OCT, 1) AND THESE AND SOV DELIVERY 60,000 TONS FORAGE GRAINS TO BE ON COMMERCIAL BASIS. RUMANIA GRANTED CREDIT FOR 450,000 TOTAL WHEAT (10 BE DELIVERED FIRST HALF 1957) AND FOR SOV EQUIPMENT FOR CONSTRUCTION "CHEMICAL PLANTS" (PROBABLY REFERS PRINCIPALLY TO 50,000 TON CAPACITY SYNTHETIC RUBBER PLANT (SEE DESPATCH).
