- 3. ACCORDING TO URIBE, THE HIGHLY VISIBLE USG ROLE IN THE JULY 29 OPERATION AROUND MEDELLIN HAS CAUSED FEAR THAT PABLO ESCOBAR WOULD RETALIATE FOR THE OVERFLIGHTS BY RESUMING A TERRORIST BOMBING CAMPAIGN IN MEDELLIN. HE ADDED THIS AT LEAST PARTLY MOTIVATED THE LETTER FROM ANTIOQUIA GOVERNOR JUAN GOMEZ MARTINEZ AND MEDELLIN MAYOR LUIS ALFREDO RAMOS CRITICIZING GAVIRIA FOR THE OVERFLIGHTS (SEPTEL).
