CARLOS ALONSO LUCIO IN EARLY OCTOBER HAS NEVER BEEN CLARIFIED AND PROBABLY CONTINUES TO THIS DAY. WITH EMBASSY'S MOVE TO A NEW CHANCERY, THE DISTRACTION OF POLITICAL EVENTS, AND THE END-OF-THE-YEAR HOLIDAYS THE ISSUE HAS NOT BEEN MUCH IN THE PUBLIC EYE.

(C) FOREIGN MINISTER RODRIGO PARDO DENIED THAT THE EMBASSY'S PHONES WERE TAPPED IN A PRESS CONFERENCE ON JANUARY 12, DEMANDING THAT EMBASSY PROVIDE "PROOF," AND TRYING TO MAKE THE NIGGLING DISTINCTION THAT THE GOC HAD NOT "OFFICIALLY AUTHORIZED" ANY PHONE TAPS ON THE EMBASSY. AT THE SAME TIME, NEWLY-APPOINTED JUSTICE MINISTER CARLOS MEDELLIN TOLD THE MEDIA THAT THE EMBASSY'S ACKNOWLEDGMENT THAT THE "DEA TAPES" WERE GENUINE HAD "SERIOUS IMPLICATIONS" FOR BILATERAL RELATIONS, ECHOING THE IDEA THAT SEGMENTS OF THOSE TAPES SUGGEST THAT THE USG IS CONSIDERING "KIDNAPPING" COLOMBIAN NARCOTICS TRAFFICKERS.
