THE OFFEENSE IS PARTICULARLY ACUTE IN A RECEENT TELEGRAN FROM AID/W CONCERNING THE FY 79 CONGRESSIGNAL PRESENTATION IN WHICH THE USAID IS ASKED TO LIST SCHOOLS UNDERTAKEN BY THIS MISSION TO CUSTS REDUCE THE APPEARANCE OF GOTENTATIOUS LEVING UNGUOTE. THE CLEAR SUPPORTITION IS THAT OUR LIFE-STYLE IS EXCEOSIVE, BOWN IN TERMS OF THE COUNTRY IN WHICH WE ARE WORKING ABOY BY COMPARISON WITH THE WAY WE WOULD LIVE IN THE UNITED STATES. MOREOVER, THE IMMERIOO OF THE WASHINGFION NESSTAGE IS THAT OUR DEDICATION TO HELP-ING THE RURAL POOR EXTENDS ONLY TO THE POINT WHERE OUR OWN CREATURE CONFORTS ARE THREATENED.
