c. Willard Mitt Romney - This record is on hand because it was previously requested and we kept a copy. It is enclosed. Mr. Romney registered with the Selective Service System on March 15, 1965, at Local Board #67, Pontiac, Michigan. He was assigned Selective Service Number 20-67-47-252. Further, he was first classified "I-SH" (Student deferred by statute high school) on April 21, 1965. On October 20, 1965, he was reclassified "2-S" (Registrant deferred because of activity in study). Next, on July 19, 1966, he was reclassified "4-D" (Minister of religion or divinity student). He was again reclassified "2-S" on February 25, 1969, and remained in this status through November 30, 1970. On December 1, 1970, Mr. Romney was reclassified "1-H" (Registrant not currently subject to processing for induction or alternative service). This was the last action taken by Selective Service concerning Mr. Romney. The "300" in the Remarks Column means that during the 1970 lottery, which took place on December 1, 1969, Mr. Romney's lottery number was 300 (out of 365) based upon his birthday. This high number was never called for induction.
