- 1. SEPTEL REPORTS ON GOJ VIEWS CONCERNING MODIFICATION OF U.S.-JAPAN BILATERAL NUCLEAR RELATIONSHIP. PLACE OF THE SEPARATE EXTRACTION METHOD WHICH IS LIKELY TO LEAD TO PROLIFERATION OF NUCLEAR WEAPONS. RECENTLY, PNC HAS REACHED THE CONCLUSION THAT EMPLOYING THE MIXED EXTRACTION METHOD FOR A COMMERCIAL SCALE PLANT IS NOT REALISTIC. THE CONCLUSION HAS COME OUT OF RESEARCH ON PRACTICAL APPLICATION OF THE MIXED EXTRACTION METHOD PERFORMED AT PNC'S REPROCESSING PLANT AT TOKAI MURA. JAPAN INTENDS TO WORK UPON THE U.S. FOR ADOPTION OF THE SEPARATE EXTRACTION METHOD FOR A SECOND REPROCESSING PLANT ON THE BASIS OF THIS

## CONCLUSION.

--AT PNC'S TOKAI MURA REPROCESSING PLANT, THE SEPARATE EXTRACTION METHOD HAS BEEN EMPLOYED, UNDER WHICH PLU-TONIUM AND URANIUM CONTAINED IN SPENT NUCLEAR FUEL ARE SEPARATELY EXTRACTED IN THE FORM OF NITRIC ACID SOLUTIONS. HOWEVER, PRESIDENT CARTER, WHO WAS COM-MITTED TO NUCLEAR NON-PROLIFERATION DURING HIS TENURE OF OFFICE AS PRESIDENT, PROPOSED THE MIXED EXTRACTION METHOD AND JAPAN'S ADOPTION OF THE METHOD FOR SPENT FUEL REPROCESSING. HIS REASONING WAS THAT UNDER THE SEPARATE EXTRACTION PROCESS THE PRODUCTION OF PURE PLUTONIUM WILL POSE THE DANGER OF ITS BEING USED IN THE MAKING OF NUCLEAR WEAPONS AND OF EVENTUAL PRO-LIFERATION OF NUCLEAR ARMS; THEREFORE, THE MIXED EXTRACTION PROCESS SHOULD BE USED SO THAT URANIUM AND PLUTONIUM ARE MIXED IN A SOLUTION, THUS MAKING IT DIFFICULT TO USE THE MATERIAL IN MANUFACTURING NUCLEAR WEAPONS.

--WHILE THE U.S. (WHICH HAS BEEN SUPPLYING JAPAN WITH ENRICHED URANIUM AS MATERIAL FOR NUCLEAR FUEL) RECOM-MENDED THE MIXED PROCESS, JAPAN INSISTED ON THE SEPARATE LIMITED OFFICIAL USE

PROCESS. THIS LED TO HEATED DISCUSSION BETWEEN THE TWO COUNTRIES. IN SEPTEMBER 1977, THE TWO COUNTRIES ISSUED A JOINT STATEMENT WHICH SAID IN EFFECT THAT (1) OPERATION OF THE TOKAI MURA REPROCESSING PLANT WOULD BE AUTHORIZED ON THE CONDITION OF ITS USING THE SEPARATE PROCESS ONLY FOR A CERTAIN PERIOD OF TIME, AND (2) ADOPTION OF THE MIXED PROCESS WILL BE A MATTER FOR FUTURE CONSULTATIONS BETWEEN THE TWO COUNTRIES AND THE FEASIBILITY OF THE MIXED PROCESS WILL BE EXPLORED USING PNC'S OPERATING EXPERIMENTAL FACILITY, ETC.

--PNC HAS SINCE BEEN STUDYING THE FEASIBILITY OF THE MIXED PROCESS BY PRODUCING MIXED PLUTONIUM-URANIUM SOLUTION USING VARIOUS KINDS OF SPENT NUCLEAR FUEL DISCHARGED FROM JAPANESE NUCLEAR POWER PLANTS. AS A RESULT, IT HAS BEEN FOUND THAT UNDER THE MIXED PROCESS THE PROPORTION OF PLUTONIUM TO URANIUM IS SUBJECT TO MAJOR VARIATIONS OWING TO DIFFERENCES IN THE BURN-UP OF FUEL IN THE REACTORS, ETC. IN THE FAST BREEDER REACTOR USING MIXED PLUTONIUM-URANIUM FUEL, THE COMPOSITION OF THE FUEL HAS BEEN STRICTLY DETERMINED. FROM THIS FINDING, PNC HAS REACHED THE CONCLUSION THAT THE USE OF THE MIXED PROCESS IS NOT REALISTIC.

--SINCE THE FATE OF THE MIXED EXTRACTION METHOD IS SUBJECT TO CONSULTATIONS BETWEEN THE U.S. AND JAPAN, WHETHER JAPAN CAN FOCUS ON THE SEPARATE PROCESS OR

NOT IS SUBJECT TO BILATERAL NEGOTIATIONS WITH THE REAGAN ADMINISTRATION. END SUMMARY.

3. COMMENT: PNC POSITION REPORTED ABOVE WILL NOT BE NEWS TO USG NUCLEAR EXPERTS. REPORT IS SIGNIFICANT PRIMARILY BECAUSE IT APPEARS AT A TIME WHEN JAPANESE ARE FULLY AWARE THAT FURTHER NEGOTIATIONS WILL SOON BE REQUIRED ON EXTENSION OR MODIFICATION OF EXISTING BILATERAL AGREEMENT ON OPERATION OF TOKAI MURA PLANT.
