

17. (C) AMBASSADOR DOBBINS TOLD THE PESHAWAR GROUP THAT THERE IS A CONVERGENCE AMONG THE OBSERVER DELEGATIONS THAT FIRM CONCLUSIONS MUST RESULT FROM THE BONN MEETING. DOBBINS SAID THAT THE BONN PARTICIPANTS CANNOT DEFER KEY DECISIONS TO SOME FUTURE MEETING. RATHER THEY MUST TURN OVER THEIR RESPONSIBILITIES TO SOME NEW INSTITUTIONS, SPECIFICALLY, A NEW INTERIM

ADMINISTRATION, SUPPORTED BY A LARGER LEGITIMATING COUNCIL, AND UNDERPINNED BY MUTUALLY AGREED-UPON GUIDELINES AND PRINCIPLES. DOBBINS NOTED THAT THE BONN DELEGATES SHOULD CONSIDER MAKING ROOM IN THE INTERIM ADMINISTRATION, AND ON THE LARGER COUNCIL, FOR IMPORTANT AFGHANS, ESPECIALLY FROM THE SOUTH, WHO HAVE BEEN UNABLE TO ATTEND THE BONN MEETING.

18. (C) DOBBINS ALSO PRESSED THE PESHAWAR GROUP FOR ITS VIEWS ABOUT THE ACTUAL ROLE OF THE EX-KING.

DOBBINS NOTED THAT THE

EMERGING CONSENSUS SEEMS TO BE THAT THE EX-KING SHOULD SERVE AS THE LARGELY CEREMONIAL HEAD OF SOME LARGER COUNCIL, COMPOSED OF 150-200 NOTABLES, WHO WOULD SUPPORT AN ADMINISTRATIVE CABINET, WHICH WOULD BE CHARGED WITH ACTUALLY RUNNING THE COUNTRY.
