A MEMORIAL MASS AT THE ROMAN CATHOLIC CATHEDRAL HAD BEEN HELD ON JUNE 21, BEFORE THE BODY HAD BEEN RELEASED BY THE POLICE. A LARGE TURNOUT IS EXPECTED FOR THE FUNERAL PROCESSION.
