POSSIBILITY WOULD BE TO USE THIS FOR A FURTHER DEMARCHE
TO COLONEL PONCE ALONG LINES OF PREVIOUS. REPSATING THAT
STORY MUST COME OUT. AND CONTINUED UNWILLINGNESS TO FACE
UP TO CHIRGES AND COUNTERCHARGES AGAINST ESAF IN JESUIT
CASE WILL BE DEATH BLOW TO INSTITUTION. MY THINKING HAS
NOT PROGRESSED BEYOND THESE TWO APPROACHES. I LEAVE IT

TO DEPARTMENT WHETHER OR NOT CHAIRMAN MOAKLEY SHOULD BE APPROACHED TO COORDINATE RESPONSE MOST LIKELY TO GET ATTRUTH, AND ADVANCE CAUSE OF JUSTICE.

THIS INFORMATION SHOULD DUICKLY BECOME AN INGREDIENT IN ALL ASPECTS OF JESUIT CASE DISCUSSION.
