This is the final response to your 11 January 2012, Freedom of Information Act (FOIA) request to the Federal Bureau of Investigation (FBI) [FBI FOI/PA #1181137-000] for all records containing information on SOLAR SUNRISE. While processing your request, the FBI located a record that fall under the purview of the United States Coast Guard (USCG). Your request was received in this office on 15 July 2013.

In responding to the FOIA request, the USCG conducted a search for additional documentation relating to the SOLAR SUNRISE that began on 16 July 2013. Unfortunately, we were unable to locate any additional records.

We are granting your request under the FOIA, Title 5 U.S.C. § 552, as amended, and DHS' implementing regulations, 6 C.F.R. Chapter I and Part 5. After carefully reviewing the USCG message traffic record, I determined that they are appropriate for public release. They are enclosed in their entirety; no deletions or exemptions have been claimed.
