ATTACHMENT: Results of Technical Interrogation Test (one copy)

1. Forwarded herewith for your information and retention is a copy of the questions and answers obtained during the interrogation of [REDACTED] under the technical interrogation.

2. The examination was conducted from 1900 until 2330, 27 August 1951 in the [REDACTED] dispensary. [REDACTED] was under the medical supervision of [REDACTED] while [REDACTED] conducted the questioning.

3. As will be noted from the trend of the attached list of questions, stress was laid upon the sensitive questions of the [REDACTED] test. The basic norm questions were intentionally centered around the known indiscretions of [REDACTED] (i.e. money matters and his living arrangements in [REDACTED]).

4. The examination ran smoothly throughout with [REDACTED] experiencing little apparent after effects. He is aware, however, that he was questioned in some connection, but is extremely "foggy" as to what happened to him.

5. With the completion of the technical interrogation test on [REDACTED] has concluded the debriefing to its own satisfaction. The consensus of opinion at this headquarters is to the effect that [REDACTED] is, up to the present time, as "clean" as can be expected, considering his relatively long association with [REDACTED]. His loyalty, although somewhat shaken by the implication of mistrust on our part in the debriefing, appears to remain strong. [REDACTED] is well cognizant of the potential controls available to the [REDACTED] Communists and is endeavoring to place [REDACTED] in such a position that our controls over him and his family exceed those available to the Communists.
