



2. EVERYONE WAS WORSHIPPING IN MEDITATION. THREE PERSONS STOOD AND MADE STATEMENT ONE WOMAN AND TWO MEN.
- A. THE WOMAN SPOKE ABOUT HOW JESUS WENT OUT INTO THE WILDERNESS AT THE AGE OF 12 AND BEGAN TO PREACH. SHE ALSO SAID JESUS DID NOT MIX POLITICS WITH RELIGION


G. Sketch Map of 2111 Address.
