SITUATION INFORMATION REPORT

The Supreme Court has just rejected without comment a legal move aimed at abolishing the NCUA. In a one sentence order, the court let stand a lower court ruling which threw out an effort by three Chicagoans to have the Committee declared unconstitutional because of the way it was set up in 1945 and because of its methods since then.

The three Chicagoans contended that the basic charter setting up the committee violated the Constitution and that the treatment of witnesses infringed on the guarantee of free speech and assembly. The three judge panel in Chicago ruled that the Committee was protected by the clause in the Constitution barring members of Congress from being questioned "in any other place" for anything they say in speech or debate in the House or Senate.

The Black Panther Party, centered in California is reported to be at odds with Ron Karcher, chairman of US, an extremist black nationalist organization in Los Angeles. It is predicted that there will be a confrontation between the Panthers and Karcher. Efforts are allegedly also being made by the Black Panther leadership to push extremist Shirley Chisholm out of the party. The action Chisholm is emphasizing black culture rather than black militancy.

Yes, Chisholm has been very active lately in Black Panther Party and Black Student Union activities at San Francisco State College. He is expected to remain in the area for sometime.

At a 1967 party commission meeting in Budapest on 21 November 1967, the Soviet Union overrode the objections of rebels among the Western Communist Parties and won agreement for a meeting of World Communist leaders in Moscow next May.

The commission also agreed to assign an eight party working group to prepare a document outlining the policy of the International Communist Movement in its "struggle against imperialism". The draft will be submitted to the next meeting of the preparatory commission in Moscow, beginning March 17. At the March meeting the exact date for the convening of the world conference will be set.

All Communist Parties, including the Chinese, Yugoslavia, and others that have boycotted all the preparatory meetings, are to be invited to take part in the Conference.

On 25 November the Soviet Communist Party in a call in the form of an authoritative policy statement in the party newspaper PLENUM, asked that allied parties throughout the world today

revolution in the U.S. audience and to warn against the dangers of the capitalist class and its role in the Socialist Revolution. The Conference is organized by leading figures from various Marxist Government parties in Europe to draw attention to the invasion of Czechoslovakia. The will identified the enemies as the revisionists and the "right-wing" and "left-wing" opportunists and splitters who are undermining the Communist and workers' movement".

In party parlance, the leading opponents are such forces as Communist China and Cuba, which preach a more militant and revolutionary communism.

Right-wing is the label applied to more nationalistic-minded communists, such as the Yugoslavs, Romanians, and those who favor a less orthodox and less Moscow-oriented interpretation of ideology.

In early November, the Provost Marshal, Ft. MacArthur, California received information from an anonymous caller that certain personnel residing in San Pedro, California who are members of the U.E.P. In this Club have plans to cause destruction before Christmas 1963 at the following installations in California: Ft. MacArthur, Ft. Irwin, March AFB, Norton AFB and Long Beach U.S. Naval Station.

CALENDAR OF ESTABLISHED SCHEDULED ACTIVITIES OF POSSIBLE INTEREST
FOR THE REMAINDER OF 1963

"Asterisked" items are either being reported for the first time or contain additional or changed information on previously reported activities.

November 15-Dec 25 *Mobile, Alabama - The Mobile County Civil Rights Movement (MCCM) and the Neighborhood Organized Workers (NOW) sponsored "Black Christmas" and "gift-buying boycott" of white merchants until Christmas - to protest the "unfair hiring practices" of downtown Mobile merchants is in progress. The picketing and other activities has resulted in five arrests of colored people to date.

November 25-Dec 2 The National Welfare Rights Organization (NWR), a militant "welfare rights" group which claims 30,000 members in seventy cities has proclaimed this period as "national get it week." The highlight will be Thanksgiving Day, November 28, when welfare recipients will stage demonstrations to say "No thanks, America" for the inadequate dole they get.

INFO announced a December "spend-the-rent" campaign in which welfare clients would keep their rent money to spend on basic needs not covered in their regular checks.

November 23

South Bend, Indiana. - The National Student Association Convention on White Racism is scheduled on this date. The University of Maryland formed a Campus Coalition Against Racism (CCAR) in early October. The research that will emanate from the CCAR will be used to represent the University of Maryland at the NSA Convention.

November 29

*The War Resisters League, a pacifist group, is sponsoring a demonstration to urge individuals to refuse to pay the 10% tax on phone bills. It is proposed that these individuals purchase money orders with the unpaid tax money and send them to the Canadian Friends Service Committee, a pacifist group, to purchase medical supplies for North and South Vietnam.

November 29-Dec. 1.

*Chicago, Illinois. - The National Convention of the Young Socialist Alliance (youth division of the Trotskyite Socialist Workers Party) will be held at the campus of the University of Chicago on Thanksgiving weekend. Young socialists from across the country will assemble.

"All who support the International Revolutionary Socialist Movement are invited to attend the convention." YSA national headquarters stated, "This convention is shaping up to be the largest convention ever held of the young socialist movement in the history of the U.S." It will set the course for the young-socialist movement for the coming months.

The YSA says the convention will feature an international panel of revolutionary socialists from England, France, Germany, Mexico, Canada, and a panel of active-duty-anti-war GI's.

Although State Department visa policy may prevent the appearance of some, among the notables expected to be there are:

Tariq ALI, a principal organizer of the October 27th London Demonstration;
 a leader of the Mexican student strike;
 a former leader of the now banned organization of the Revolutionary Communist Youth (JCR) of France;
 Leaders of the German Socialist Students Federation (SDS);
 Members of the Canadian Socialist League (Ligue des Jeunes Socialistes);
 George NOWAK, renowned marxist author and lecturer.

November 27-Dec 1

Montreal, Canada - A Hemispheric Conference to End the War in Vietnam will meet to develop "coordinated resistance strategy against U.S. foreign policy of imperialism and neo-imperialism in the attempt to police the whole world and make it safe for capitalist exploitation." "Latin America is likely to be the next locus of 'police action'." "U.S. imperialism is a hemispheric problem - the strategy for change must be equally hemispheric."

Among those scheduled to participate:

Dr. Cicodi JAGAN, leader of People's Progressive Party in Guyana, former Prime Minister.

The Ft. Hood Three - Dennis MORA, James JOHNSON, David SIMS - The first GI's to resist assignment to Vietnam and recently released from prison and discharged from the U.S. Army.

Representatives of the National Liberation Front - Hoang Bich Son and Huynh Van Bin

Representatives of Democratic Republic of Vietnam - Prof. Hoang Minh Giang - member of parliament - Le Duy Von - secretary of Vietnam Peace Committee
Wilfred Purchett - Communist supporting news correspondent and author.

November 30

The Vietnam West Committee, which is controlled by the Young Socialist Alliance, a communist group, plans to distribute antiwar leaflets at the Army-Navy football game.

December 1968

Author Norman MAILER, will appeal his conviction on charges of unseemly and disorderly conduct during the October 1967 peace march on the Pentagon. Sentenced to five days in jail by a U.S. Commissioner, the appeal will be to the 4th U.S. Court of Appeals.

December 2

Washington, D.C. - The Local Emergency Committee on The Transportation Crisis (ECTC) has called for a Total boycott of D.C. transit from 5:AM through the P.M. rush hours as part of Washington Transportation Crisis Week to protest the recent fare hike. The ECTC continues to take a threatening and militant stand concerning both the DC Transit Co. and proposed freeways for D.C.

December 1-5

Princeton, New Jersey - It can be anticipated that the U.S.A. will be soundly chastised as well as praised when more than eighty leading intellectuals from throughout the world will gather at the Institute for Advanced Studies to assess many of the problems that

will comment the next Mexico City Incident.

Plans for the five-day seminar on "The U.S. - Its problems, Impact and Range in the World" were to be announced on 26 October in London and in Paris by Shepard STONE, President of the International Association for Cultural Freedom. The Association is a private organization as secular, tolerant, and open of public view as the most progressive and liberal organizations throughout the world.

December 1

Mark RUDD, leader of the student rebellion at Columbia University last spring; is scheduled for a pre-induction physical examination. RUDD, head of the Columbia Chapter of the SDS and outspoken Vietnam War protester has appealed his 1-A classification on the grounds that he is a "revolutionist." Demonstrations in support of RUDD's draft resistance stance can be anticipated.

December 2

Oakland, California - The April 6, 1969, "shoot-outs Creek" of the Black Panther Party have had their trial set for 2 December. Eldridge CLEAVER, Minister of Information of the BPP is one of the defendants. All pleaded innocent to a variety of charges stemming from the shoot-out with the Oakland Police Department in Oakland.

December 2

New York City, New York - On November 22, Adam Clayton POWELL Jr. parole on a pending maximum jail sentence of 90 days for criminal contempt of court was extended until 2 December. Unless either the appellate division or the Court of Appeals extends the stay again, POWELL will be subject to arrest in the state. If he fails to surrender, the court will institute an additional contempt proceeding against him. POWELL, who was easily reelected to the House of Representatives on November 5, is expected to return to his seat in January 1970 after having been excluded for "gross misconduct." Whether he will be seated with full seniority - if at all - is a moot question.

December 3

Jerry RUDIN, Youth International Party (YIPPIE) leader, accused of soliciting mob action during the Democratic National Convention last August will be tried in criminal court (Chicago). Sympathy demonstrations during the trial are probable. On 10 November RUDIN was ordered to remain in Illinois until his trial.

December 5

New York City - The GUARDIAN, self-styled independent radical newspaper, holds its 20th anniversary celebration at the Fillmore East.

GUARDIAN says - "One of the best known figures on the radical left will join in celebrating the **GUARDIAN**'s 20th birthday in New York, Thursday, December 5. It promises to be one of the most politically important meetings of the year."

Speakers include: H. Rap BROWN, former Chairman of SNCC; Herbert MARCUS, Professor at University of California; and Carl OGLESBY, former President of SDS.
Chairman of the meeting: Bernadine D'ARETTO, SDS organizational secretary.
Entertainment: Pete SEEGER

Acting General Manager William ROSE will speak on behalf of the **GUARDIAN**. He will discuss the **GUARDIAN**'s role in the development of an effective radical movement and his experiences in Cuba and No. Korea, from which he recently returned.

December 6

*Baltimore, Maryland - A new date for the trial of H. Rap Brown will be set when Chief Federal Judge Roszel C. Thompson makes his decision relative to an argument made 25 November by BROWN'S attorney that the change in venue in Brown's trial on arson and riot charges in Maryland courts violated his constitutional rights.

New York Civil Liberties lawyer, William H. Muntaser claimed the Constitution guarantees defendants trials in the jurisdictions where they are accused of committing crimes. The trial had been ordered moved from Dorchester County to Frederick County upon request of the state; whereas now Muntaser claims the defendant who pleads for venue change based on the position that a fair trial would be improbable in the locus of the crime or activity.

December 7 and 8

Tech Force - the underground newspaper published in San Francisco - aimed at servicemen and veterans - carried a notice in its October 25 edition calling for GI actions December 7 and 8: "1. Organize & teach-ins, rallies, marches, discussions, GI dinners, etc. 2. Contact - local vets, student anti-war groups for assistance. 3. Write - P.O. Box 31263, San Francisco, 94131, so we can inform you of what's happening around the country."

December 8

Tacoma, Washington - The GI-Civilian Alliance for Peace is planning a GI march for December 8, which it hopes will attract 5,000 demonstrators.

December 9

Although the trial of Sirhan B. SINNOWER, accused of murdering Robert F. KENNEDY, is scheduled to begin

December 9, it probably will be postponed until after the first of the year. A hearing is scheduled for the week of November 24 and it is expected that Defense Attorney Russell E. PARSONS will ask for a continuance on the grounds that another attorney coming into the case is still engaged in another trial and will need time to study the LEMAN case.

December 13

New York City - The National Emergency Civil Liberties Committee annual Bill of Rights dinner is scheduled for the Americana Hotel. The NECLC is the old NCLC rejuvenated with a new name. The old NCLC was cited as a Communist Front in 1956 by the Senate Internal Security Subcommittee and in 1959 by HCUA. Featured speakers will be: Dr. Benjamin SPOCK and Dick GREGORY.

Corliss LEONET is chairman of NECLC.

December 21

Washington D.C. - The HCUA subcommittee after holding three days of open hearings into the conduct and connection of some groups and individuals in the NIC disorders is in recess until 21 December. Five of the seven witnesses subpoenaed have not been heard and are expected to return. They are David MILLINGER, Rennie DAVIS, Tom HAYDEN, Jerry RUBIN, and Abbie HOFFMAN. Robert GREENBLATT of the NIC and Dr. David YOUNG of the Medical Committee for Human Rights who testified that week were released from their subpoenas but could be summoned back.

Abbie HOFFMAN was convicted in D.C., November 20, of defiling the American Flag by wearing a shirt that looked like one during a Capitol Hill demonstration on 3 October. He was sentenced to pay a fine of \$100 or serve thirty days in jail. Execution of the sentence was deferred pending an appeal.
